**OBSERVATIONS AND CORRECTIVE ACTIONS:**

- 14)** Slicer is reportedly cleaned with sanitizer. Base of slicer (and un-removable blade) must be washed, rinsed and sanitized in place.
- 33)** Clean shelves where "clean" glassware is stored (including inside walk-in cooler) to remove dust, debris and residues.
- 34)** Provide test strips for sanitizer at dishwasher and bar utensil sink. Check sanitizer daily.
- 35)** Clean ice dispenser at soda machine to remove some residues.
- 45)** Clean floors in hard to reach areas (i.e. behind/under equipment/shelving) throughout facility to remove trash, food debris, and misc. residues.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
