Seal wood used to support utensil bins in wait station so as to be smooth and easily cleanable or replace with cleanable materials. Clean shelves under rubber netting where clean glassware is stored in bar to remove dust.

35) Replace domestic equipment (microwave/refrigerator) with NSF approved commercial equipment once existing equipment is not operable.

45) Clean floors in hard to reach areas (i.e. under/behind equipment/shelving) to remove misc. debris and residues.
