OBSERVATIONS AND CORRECTIVE ACTIONS

- 7, 39)** Air temperature of domestic refrigerator next to cook line was 45-50°F upon inspection. Food temperatures were 41-50°F. Repair/adjust refrigerator so that it maintains potentially hazardous foods at or below 41°F. Replace missing thermometer.
- 9)** Observed soup (127°F) cooling in covered, deep container in walk-in cooler. Soup was transferred to an uncovered, shallow pan to continuing cooling during inspection.
- 14)** Clean inside beverage guns in Lounge bar to remove accumulation of residues
- 33)** Adjust bottom shelves in storage room so that shelves are at least 6 inches off the floor.
- 35)** - Replace domestic equipment (i.e. refrigerator, microwaves, etc.) with NSF approved commercial equipment.
- Replace ice bins in Lounge bar with NSF approved ice storage bins with integral cold plates so that liquid waste drain lines do not pass through storage bin.
