OBSERVATIONS AND CORRECTIVE ACTIONS:

- 1) Food safety certificate is reportedly lost; waiting for replacement in the mail. Provide this Department a valid food safety certificate for at least one current employee within 60 days.
- 6) Both hand sinks were blocked by food/dishes. Hand sinks should be accessible for proper hand washing.
- 7) Observed gravy at 104-119°F on countertop, reportedly for 30 minutes. Gravy was moved to walk-in for proper cooling.
- 35) Replace domestic microwave with NSF approved commercial unit once existing units is inoperable.
- 40) No sanitizer observed in sanitizer container. Sanitizer was changed during inspection.
- 44) Remove unused equipment/utensils on back counter top so as to facilitate cleaning.

Reinspection fees will be charged for all subsequent reinspection unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
