OBSERVATIONS AND CORRECTIVE ACTIONS: 9- Observed cooked vegetables (66°F-79°F, 1 ½ hours) cooling at depths of 3 inches (edges of pan) to 5+ inches (middle of pan). When cooling cooked foods, ensure food is level in pan so that all food being cooled reaches 70°F within 2 hours.

Note: Vegetables separated into two pans during inspection to complete the cooling process.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
