OBSERVATIONS AND CORRECTIVE ACTIONS

- 30- Observed condiments and containers of soy sauce, minced garlic, etc. stored in cardboard box in walk-in refrigerator. Store all foods in easily cleanable, nonabsorbent containers.
- 31- Food handler reports nozzles on beverage machine are cleaned every other day. Clean daily. Clean around nozzles of beverage dispenser to remove accumulated residues.
- 33- Observed duct tape securing loose laminate on counter across from grill. Remove tape and repair properly to facilitate cleaning.
- 35- Observed pink residues in ice machine and accumulated residues in beverage gun holder. Clean. Replace ice bins in bar with NSF approved integrated ice bins within six months.
- 44- Observed wet mop stored in mop bucket. Store mop so as to dry completely between uses.
- 45- Observed cracks in vinyl at multiple corners throughout facility. Repair to prevent entrance of water/further damage to flooring.
