- 6) Fill empty paper towel dispenser at hand sink in wait station.
- 35) Repair or replace broken insulation panel on the ice machine lid. Replace ice bin with an NSF approved ice storage bin with an integral cold plate so that liquid waste drain lines do not pass through storage bin within 6 months.
- 38) Replace missing light cover in the hood.
- 45) Clean floor in walk-in cooler to remove spilled beer.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
