- 48) On 6/26/09, this Department requested a plan review application be submitted for the new oven (addition of grilled chicken). No plan review application has been received. Provide this Department a plan review application and fees for minor remodel with 15 days.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
