OBSERVATIONS AND CORRECTIVE ACTIONS:

- 9) Cooked foods are reportedly covered while cooling. Cooked foods must be uncovered while cooling. Cover food once they are 41°F or below.
- 33) Finish/seal bare/worn wood shelves in back storage area so as to be smooth and easily cleanable.
- 35) Observed misc. debris and dirt on tray where ice scoop is stored. Ice scoop was removed for cleaning during inspection.
- 39) Replace broken probe thermometer. Thermometer must be readily available for checking cooking/hot holding temperatures

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
