**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 21- Hot water 113°F at utensil sink faucet. Adjust/repair hot water heater to maintain minimum temperature of 120°F.
- 28- Reported apples placed at customer self service counter are not washed. Wash all ready-to-eat fruit before placing at self-service counter.
- 30- Observed canned soda stored in ice chest with standing water. Maintain ice/keep water drained to prevent contamination by customer hands.
- 31- Clean behind nozzles of beverage dispenser to remove accumulated residues.
- 33- Observed a few areas of damaged/worn laminate at utensil sink and cabinets (trash receptacle) by coffee brewer. Repair to be smooth and easily cleanable. Clean inside cabinets under coffee brewer, iced tea dispenser and beverage dispenser to remove residues.
- 35- Observed cardboard taped to freezer door by ice cream bars. Remove tape/cardboard to facilitate cleaning. Clean inside ice machine to remove black and pink residues and adjust air flow panels at top of sandwich display refrigerator so as to be seated properly.
- 44- Observed mop stored in bucket of dirty water. Store mop so as to dry completely between uses. Raise chain securing CO2 tanks to mid-tank to prevent accidental tipping of tanks.
- 45- Observed water damage/peeling dry wall on ceiling in back store room. Repair. Clean floors in hard to reach areas (under ice machine, shelves in back room, etc.) to remove accumulated dust/miscellaneous trash.
- 52- Organize back room to facilitate cleaning and prevent harborages.
