- 21)** Hot water at janitorial sink was 109°F rather than 120°F as required.
- 38)** Provide a probe type thermometer for checking hot holding temperatures.
- 45)** Repair/finish off wall behind display freezer so as to be smooth, non-absorbent and easily cleanable.
