- 35)** Replace domestic microwave with NSF approved commercial unit.
- 42)** Provide a separate and designated area for spoils and returns.
- 45)** Clean floors under display shelves in walk-in cooler to remove broken glass and orange residues.
Repair damaged areas of floor coving (by utensil sink) so as to be smooth, non-absorbent, durable and easily cleanable.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
