OBSERVATIONS AND CORRECTIVE ACTIONS

- 14- Remove unused equipment, papers, etc. from kitchen area to provide easily cleanable area for candy making and storage of candy making supplies. Owner reports utensil cleaning procedure of wash and rinse. Proper utensil cleaning procedure is 1. Wash with hot, soapy water, 2. Rinse with clear water, 3. Sanitize with approved sanitizer (i.e.: 1 oz bleach to 4 gallons water), 4. Air dry on clean drain board.
- 15- Observed apricot bread and roasted nuts in plastic baggies at front counter. Reported bread and nuts are made/roasted in home oven. Discontinue making/roasting foods at home. All foods offered for sale in facility shall be made on site.
- 32- No ingredient list available for home-made chocolate candies or manufacturer label on bagged ice. Provide.
- 33, 45- Remove/organize unused equipment/miscellaneous items from floor and shelves to facilitate cleaning and prevent harborages.
- 35- Observed black residues in back of dairy display refrigerator. Clean. Replace domestic microwave with NSF approved commercial unit once current unit becomes non-operational.
- 52- Observed personal foods mixed in with foods offered for sale in freezers/refrigerators on display floor. Designate area for personal food storage and clearly label.
