OBSERVATIONS AND CORRECTIVE ACTIONS: 33- No back on cabinets at customer self service counter. Provide to prevent harborages.
 35- Observed domestic chest freezer and microwave in use. Replace with NSF approved commercial units. Clean inside ice machine to remove residues.
 36- Observed unchained CO2 tanks under beverage machine. Secure to rigid structure. Provide tongs at jerky containers stored on rack in middle of store. Note: Tongs available at jerky container at front counter.
 38- No shatterproof light covers on lights over ice machine, utensil sink or beverage machine. Provide.
 44- Observed wet mop stored in mop bucket. Store mop so as to dry completely between uses.
 45- Observed exposed wood and damaged ceiling panels over customer self service counter and damaged areas, gaps and separating/lifting vinyl on floor at both ends of customer self service counter. Repair where needed to be smooth and easily cleanable.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
