- 35- Clean nozzles on beverage machine of accumulated buildup. Wash, rinse and sanitize nozzles daily.
- 36- Observed ice scoop sitting on box. Store ice scoop in ice bucket only. No tongs at pickled egg container. Provide.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
