OBSERVATIONS AND CORRECTIVE ACTIONS: 7, 35- On arrival, observed assorted deli foods (chunked avocado, sliced tomatoes, sliced cheeses/meats, etc.) at 46°F-49°F in top of prep refrigerator and water pooled on floor throughout kitchen. Reported prep refrigerator unplugged last night for defrosting. Do not unplug any refrigerator storing potentially hazardous food. Also observed display refrigerator to be unplugged. Food handler reports unit non functioning on her arrival one hour prior to inspection due to high water in kitchen area. Reported sandwiches, meats and burritos stored in display refrigerator moved to walk-in refrigerator one hour prior to inspection. Internal temperature of burritos/sandwiches 44°F-49°F during inspection. Do not store potentially hazardous foods in display refrigerator until unit is capable of maintaining foods at 41°F or below (which may require air temperature of 38°F-39°F). No foods observed hot holding during inspection. Reinspection on hot holding to follow in 3+ days.

30- Observed beverage syrup boxes stored on floor in walk-in refrigerator to be saturated. Relocated wet boxes to approved shelving to facilitate cleaning.

Note: Only cans and bottles in original shipping containers may be stored directly on floor.
