OBSERVATIONS AND CORRECTIVE ACTIONS: 7- Observed eight cases of yogurt (45°F-47°F) stocked over air vents/top of containment barrier in refrigerated island in dairy section. Keep foods below air vents so as to maintain at 41°F or below. Observed yogurt drinks and large containers of yogurt (44°F-49°F) in section of display refrigerator by eggs. Adjust/repair.

39- Observed thermometer directly above bean sprouts and hummus in produce section to be malfunctioning (reading 70°F; Inspector's thermometer 38°F). Repair/replace.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
