**OBSERVATIONS AND CORRECTIVE ACTIONS:**

- 34- No test papers available for checking sanitizer level in sanitizer compartment of utensil sink. Provide. Clean the drying area of the utensil sink of rust and old steel wool.
- 35- Hot holding unit for brats and tamales not working during inspection. Repair/ replace hot holding unit. (Unit is not presently being used). Replace torn seals on doors to beer and soda coolers.
- 39- Provide a digital probe thermometer for checking the temperature of cooked brats and tamales.
- 45- Clean wall behind beverage boxes of syrup residues.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
