Air temperature at display shelves 44°F-50°F; air temperature of walk-in refrigerator 39°F. Adjust/repair unit to maintain potentially hazardous foods at 41°F or below and relocate beverage cases stacked behind burrito/sandwich display so as to provide adequate air flow.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
