OBSERVATIONS AND CORRECTIVE ACTIONS:

- 29)** Remove canisters of round up and Raid from facility as it is not approved for use in a food facility.
- 32)** Provide complete labels for self packaged ice (i.e. facility name, address, contact info). Repeat Violation.
- 35)** Replace domestic microwave with NSF approved commercial unit once existing unit breaks.
- 35, 45)** Observed leaks inside walk-in cooler. Water is pooling on floor of cooler. Operator reported there may be a crack in the wall and the condenser is leaking. Repair leaks in wall and condenser as needed to keep floor clear of pooled water within 6 months.
- 45)** Clean floors under shelving in walk-in cooler to remove trash, broken glass and misc. debris.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
