 33- Remove cardboard lining shelves in refrigerator at dairy display to facilitate cleaning and air flow.
 39- No thermometer at dairy or sandwich displays in refrigerator. Provide.
 44- Observed mop stored in mop bucket full of dirty water. Store mop so as to dry completely between uses.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
