- 14,- Hot water at utensil faucet at 114°F. Adjust so as to maintain temperature of no less than 120°F. Wash, rinse and sanitize tongs for beef jerky daily.
- 34- No test papers were available for checking sanitizer level in sanitizer compartment of utensil sink. Provide.
- 52- Securely chain / secure carbon dioxide canister to wall.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
