- 7)** Walk-in cooler is 45°F in area where dairy products are displayed. Bottom shelf of display cooler is 43-45°F where burritos stored. Repair coolers so as to maintain potentially hazardous foods at or below 41°F.
- 33)** Remove cardboard from storage shelves in walk-in cooler as it is not approved for use with food storage. Use easily food grade materials only.
- 45)** Clean floors in hard to reach areas (i.e. under/behind equipment/shelving) to remove misc. debris and dust.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
