OBSERVATIONS AND CORRECTIVE ACTIONS:

- 27, 18- A few boxes of wrapped birds (custom processed food) observed on shelf in walk-in cooler. Either provide separate storage facilities (refrigeration) for storage of the custom processed food (birds) or develop a HACCP plan for storage of the custom processed food in bar walk-in cooler.
- 34- Obtain test papers for checking sanitizer level in bar sink, also in container for cleaning rags.
- 35- Clean bottom of beer cooler of some residues.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
