OBSERVATIONS AND CORRECTIVE ACTIONS

- 7, 35- Under counter hot dog refrigerator: air temperature 50° F, corn dog 49° F at time of inspection. Adjust/ repair refrigerator as needed so as to maintain potentially hazardous foods at 41° F or less.
- 27- Temperature of potentially hazardous foods reportedly not being checked at time of delivery.
- 29- Spray bottles of chemicals observed hanging over handsink backsplash.
- 35- a) Clean slushy machines of sticky residues (ie: drip trays).
b) Clean top shelf of undercounter hot dog refrigerator of some rust.
- 36- Self-serve disposable customer utensils (spoons) observed in box with handles in both directions—spoons rearranged during inspection so that handles are all in same direction. Note: OK to use wrapped spoons.
- 45- a) Clean floors, under shelves/ equipment of misc. debris and some dust accumulation (ie: in walk-in cooler).
b) Replace worn, absorbent marlite wall panels at janitorial sink. Replacement shall be FRP panels, stainless steel or equivalent.
- 52- Absorbent cardboard splash shield observed on shelf next to hot chocolate dispenser—removed during inspection. OK to use non-absorbent, easily cleanable (ie: plastic or plexiglass) splash shield if needed.
