OBSERVATIONS AND CORRECTIVE ACTIONS

33- a) Replace worn, hard to clean shelf in cutting board storage cabinet.

b) Clean cabinet shelves where needed (ie: under rubber netting) of some dust accumulation. Organize items stored in some cabinets so as to eliminate clutter and facilitate cleaning.

35- Milk crates being used as storage supports in back storeroom—provide additional shelf units/ dunnage racks as needed.

36- Remove absorbent paper liners under cups at self-serve beverage dispenser in dining room.

41- Repair leaking faucet at dishwasher prespray sink.

45- a) Repair damaged wall below/ behind dishwasher. OK to use FRP or stainless steel wall panels.

b) Clean floors, in hard to reach areas (ie: around storage freezers) of some accumulation of dust, etc.
