OBSERVATIONS AND CORRECTIVE ACTIONS

- 27- Verify that temperatures of potentially hazardous foods are routinely checked at time of delivery.
- 30- No label on ice bucket.
- 35- Repair leak (some water observed on lower shelf) under beverage dispenser at drive thru window.
- 36- Clean knife rack (near prep sink) of some dried residues.
- 39- Replace missing thermometer in undercounter refrigerator at main prep line.
- 41- a) Repair broken drain plug assembly at middle compartment of utensil sink.
b) Repair leaking utensil sink drain line.
- 45- Clean floors, in hard to reach areas, of some misc. debris.
