OBSERVATIONS AND CORRECTIVE ACTIONS:

- 35- Replace ice bin (used for beverage ice), equipped with separate beverage line cold plate, with an ice bin which has an integral cold plate
- 34- Obtain test papers for checking sanitizer level in sanitizing compartment of bar sink. Do not mix bleach in soapy water for washing glasses.
- 45-Replace peeling, hard to clean marlite wall panels behind bar sink and hand sinks in restrooms. Replacement shall be FRP wall panels, stainless steel or equivalent.
- 44- Back door open at beginning of inspection—closed during inspection. Keep back door closed or provide screen door.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
