OBSERVATIONS AND CORRECTIVE ACTIONS:

- 34- Obtain test papers for checking sanitizer level in sanitizing compartment at utensil sink.
- 35- a) Refinish rusted areas of upright storage refrigerator so as to be smooth, easily cleanable, non-absorbent and in good repair.
- b) Replace ice bin (used for beverage ice), equipped with separate beverage line cold plate, with an ice bin which has an integral cold plate within the next 6 months.
- 44- a) Employee's personal items observed on undercounter refrigerator—move to drawer during inspection.
- b) Back door propped open. Keep back door closed or provide screen door.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
