OBSERVATIONS AND CORRECTIVE ACTIONS

- 4- Some employee's drink glasses observed without lids.
- 33- a) Clean shelves (ie: in cabinets), especially in hard to reach areas of some food debris and dust accumulation.
b) Adjust hard to close cabinet doors below blender sink.
- 35- Replace split door seal on 2-door storage refrigerator in back prep area.
- 40- No sanitizer in container for cleaning rag at front espresso machine. Sanitizer concentration low in container for cleaning rag at drive thru espresso machine. Use test papers to check sanitizer concentration in cleaning rag containers.
- 45- Clean floor, especially in hard to reach areas, of some food debris.
