OBSERVATIONS AND CORRECTIVE ACTIONS:

- 21- Hot water 115° F at utensil sink faucet—adjust water heater.
- 27- Temperatures of potentially hazardous foods reportedly not being checked at time of delivery—use probe thermometer to check temperatures.
- 34- Wash (hot, soapy water), rinse and then sanitize utensils. Use test papers to check sanitizer concentration.
- 35- Clean bottom of ice cream storage freezers of some food debris.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department.
