**NEW APPLICANTS AND RENEWALS:** Complete and return the attached registration form with \$141.00 (payable to "Butte County") to the address shown above. **Seating is limited; late registrations may not be accepted. (This is a first come, first serve basis)**

Applicants can register and pay to obtain a study book from the Oroville office between the hours of 8:00 a.m. and 5:00 p.m., weekdays. If you already have a study book or have access to one, you may choose to attend the class and test by submitting the attached registration form with \$60.00. NOTE: If you are renewing a ServSafe certificate from 2006 or earlier, your book is out-of-date, and you may want to pay \$141.00 for a new book, and to take the class and test. **Note: (We do not mail the study book it has to be picked up at our office location)**

**RETEST APPLICANTS ONLY:** Complete and return the attached registration form with \$42.00 (payable to "Butte County") to the address shown above. **Please submit a copy of your letter from Environmental Health or ServSafe stating that you have not passed the ServSafe test. Only those who have taken the ServSafe test and not passed can qualify for a retest fee of \$42.00. If you have not passed and it was not a ServSafe test, you must pay the full amount of either \$60.00 or \$141.00 if you need the study book.**

All tests and books will be ordered in English unless you indicate otherwise on your registration form. Study books are currently available in English, Spanish and Chinese. Tests are available in English, Spanish and Chinese. **Movies in Spanish will be shown during the lunch hour.** (Those who watch the Spanish movies can go to lunch during the last movie after lunch break.) Test will start around 1:30 p.m. Anyone who is only taking the test or retest and not sitting in for the whole class should show up by 1:20 to check in. Test will take about an hour but we have the room until 3:00 p.m. for those who need more time.

If you have any questions or are unable to attend the class and test, please call the Oroville office at 891-2727, or 538-7281 between 8:00 a.m. and 5:00 p.m., weekdays. **If you need to reschedule the class, there could be a \$42.00 reseating fee.**
