On August 19, 2011 in addition to the normal patrol level staffing, the Butte County Sheriff's Office fielded a team of 7 Deputies, 2 Sergeants and 1 Reserve Deputy to participate in the Sheriff's Targeted Enforcement Program (STEP). The purpose of this program is to serve arrest and search warrants, conduct probation and parole searches and to saturate areas of the county where there has been an increase in criminal activity. This program is designed to cost the county no overtime expense.

Through the course of the day's activities, the team conducted numerous parole searches and 55 attempts to serve outstanding arrest warrants at various locations throughout Butte County. As a result of the parole searches and arrest warrant services, the following subjects were arrested during the course of the day:

Broadway, Michael (DOB: 03-15-69) from Oroville, was arrested on two outstanding warrants. One misdemeanor for violation of probation (bail \$10,000) and one felony warrant for violation of probation (No Bail).

Burgess, Toby (DOB: 07-24-63) from Oroville, was arrested on numerous outstanding misdemeanor warrants stemming from traffic violations to violation of probation (bail \$95,000).

Deck, Richard (DOB: 05-10-77) from Oroville, was arrested for a no bail parole violation.

Falsone, Timothy (DOB: 10-18-68) from Oroville, was arrested for a no bail parole violation.
