RESIDENTIAL BURNING GUIDELINES FOR BUTTE COUNTY

It must be a permissible burn day. Burn day status is determined by Butte County Air Quality Management District for all areas of Butte County. Visit bcagmd.org or call **530-332-9407** or toll free **855-332-9407**.

- **CAL FIRE lifted the burn suspension October 13, 2023. As of November 13, 2023, Residential Dooryard Burning without a permit is allowed on permissible burn days.**

Residential Burning in the Unincorporated Areas of Butte County

CAL FIRE/Butte County Fire Department Burn Permits required on or before May 1 each year

- Burn hours are 6:00 am to 11:00 am each permissible burn day
- 4' x 4' pile maximum size
- 10' clearance to soil surrounding pile
- Adult must be in attendance
- Must have means to extinguish pile: garden hose, bucket of water or tool
- Only vegetative waste grown on property may be burned, vegetation must be dry

After the lifting of the burn suspension until the end of declared fire season

- Burn permits are required.
- Burn hours are 8:45 am to 1 hour before sunset. Burn day status is available at 8:30 am daily.
- All other regulations are the same as above

Current: No Permit required after the end of declared fire season in the winter months

- Burn hours are 8:45 am to 1 hour before sunset. Burn day status is available at 8:30 am daily.
- If the homeowner lives on a lot equal to or less than 1 acre, burn piles can only be 4' x 4' in size. Lots larger than 1 acre can have burn piles larger than 4' x 4' in size.
- All other regulations are the same as above

Residential Burning in the Upper Ridge/Magalia (Unincorporated Area of Butte County)

- Burning is allowed in the Upper Ridge/Magalia Area on all lots **greater** than one acre in size on any permissible burn day.
- Burning **on a lot less than one acre in size** shall only be conducted by zone from January – June
 - North of Wycliff Way/Perry Road the 1st through the 15th of each permissible month
 - South of Wycliff way/Perry Road the 16th through the end of each permissible month

Residential Burning in the Town of Paradise

- Burn hours are 8:45 am to dusk each permissible burn day, 6' x 6' pile maximum size
- Burning is typically suspended June 1st each year until the fall – during CAL FIRE declared Fire Season

Residential Burning in the City of Biggs

Within the city limits of Biggs burn permits are required **year-round**. Within the city limits residents can burn **all year** on permissive burn days. Residents outside of city limits must follow the rules for the unincorporated areas of Butte County.

Between the dates of May 1st through October 31st

- Burn hours are 6:00 am to 11:00 am each permissible burn day

Between the dates of November 1st through April 30th

- Burn hours are 6:00 am to 2:00 pm each permissible burn day

Residential Burning in the City of Gridley

Within the city limits of Gridley burn permits are required **year-round**. Within the city limits residents can burn **all year** on permissive burn days. Residents outside of city limits must follow the rules for the unincorporated areas of Butte County.

Between the dates of May 1st through October 31st

- Burn hours are 6:00 am to 11:00 am each permissible burn day

Between the dates of November 1st through April 30th

- Burn hours are 6:00 am to 5:00 pm each permissible burn day

Residential Burning in the City of Oroville

Burn Permits required year-round, burn hours and locations determined seasonally by jurisdiction.

Residential Burning in the City of Chico

Burning is **always prohibited**, regardless of lot size, within the Chico city limits.

Residential Burning in the unincorporated areas of the Chico Sphere of Influence

Burning is only allowed on residential lots that are at least 0.90 acre in size.

Permits Required May 1 or sooner

- Burn hours are 6:00 am to 11:00 am each permissible burn day

After the burn suspension is lifted in the fall or winter, Burn Permits are still required until the end of declared fire season.

- Burn hours are 8:45 am to one hour before sunset. Burn day status is posted by the Butte County Air Quality Management District at 8:30 am each day
