Formation Description: The Loan Administration Board (LAB) was formed in 1986-87 as a result of the U.S. Economic Development Administration (EDA) funding a \$500,000 revolving loan fund (RLF). The LAB is governed by the US EDA, and bylaws govern the parliamentary operations of the LAB.

Function / Purpose: 3CORE, Inc. is a private, non-profit corporation that works as the economic development planning and coordination agency for the Tri-County region, composed of Butte, Glenn, and Tehama counties and the nine member cities located therein. The LAB advises staff on all matters relating to loan activities sponsored by 3CORE, Inc.

Structure: There are a maximum of 14 members on the LAB composed by the following: One (1) regular member appointed by the Butte County Board of Supervisors; One (1) regular member appointed by the Glenn County Board of Supervisors; One (1) regular member appointed by the Tehama County Board of Supervisors; and eleven (11) members appointed by the Board of Directors, to be selected from professionals with legal, accounting, banking real estate, and business counseling expertise. At a minimum, at least five (5) slots on the LAB shall be filled by banking professionals. At least seven (7) members shall constitute a quorum, and a majority of the quorum shall take action on behalf of the LAB. All members present shall count towards the quorum and shall be entitled to vote.

Terms: The term for each member appointed by the Board of Supervisors in Butte, Glenn and Tehama counties shall be determined by the governing agency. The member appointed by the Butte County Board of Supervisors shall serve for a period of two (2) years, without limitation. All other members appointed by the 3CORE Board of Directors may serve without limitation until resignation or replacement.

Formation Description:	Public Utilities Code section 21670 established that every county in which there is located an airport, whether or not it is served by a scheduled airline, but is operated for the benefit of the general public, shall establish an airport land use commission. The Butte County City Selection Committee adopted Resolution No. 84-2 dated June 28, 1984, instituting the Airport Land Use Commission (ALUC).
Function / Purpose:	The purpose of the Commission is to protect the public health, safety, and welfare by ensuring the orderly expansion of airports and the adoption of land use measures that minimize the public's exposure to excessive noise and safety hazards within areas around public airports to the extent that these areas are not already devoted to incompatible uses.
Structure:	The Commission consists of seven (7) members, to be selected as follows: Two (2) representing the cities in the County, appointed by the City Selection Committee; two (2) members representing the County, appointed by the Board of Supervisors; two (2) having expertise in aviation, appointed by a selection committee comprised of the managers of all the public airports within the County; and one (1) representing the general public appointed by the other six (6) members of the Commission. Each member shall promptly appoint a single proxy to represent him or her in commission affairs and to vote on all matters when the member is not in attendance.
Terms:	The term of each Regular Member shall be four (4) years and continue until the appointment and qualification of a successor. The expiration date of the term of each Member shall be the first Monday in May, or the next regularly scheduled meeting, in the year in which his or her term is to expire.
Meeting Dates and Location	Meetings are typically held on the third Wednesday of each month, as needed, at 9:00am, in the Board of Supervisors Chambers, 25 County Center Drive, Suite 205, Oroville, CA 95965.

Formation Description:	Revenue and Taxation Code 1620 provides that the Board of Supervisors of any county may by ordinance create an assessment appeals board for the county to equalize the valuation of taxable property within the county for the purpose of taxation. Board of Supervisors Ordinance No. 1114 established the Assessment Appeals Board on September 22, 1970. On September 12, 2017 Ordinance No. 4130 increased the payments of the Assessment Appeals Board members. Resolution No. 84-111 adopted the Rules of Notice and Procedures of the Assessment Appeals Board.
Function / Purpose:	The Assessment Appeals Board considers appeals filed by taxpayers if the assessed value of his or her property cannot be agreed upon with the County Assessor. The Assessment Appeals Board is a quasi-judicial body consisting of impartial persons, who hear evidence from both the taxpayer and the County Assessor before deciding upon the value of the property in question.
Structure:	The Board shall consist of three (3) members appointed by the Board of Supervisors. Members must have five (5) years of experience as a lawyer, Certified Public Accountant, licensed real estate broker, property appraiser, or is a person who the nominating member of the board of supervisors has reason to believe is possessed of competent knowledge of property appraisal and taxation.
Terms:	Appointments are for three (3) year terms and expire the first Monday in September three years from the date of appointment. Upon expiration of a term, the members shall continue to serve until such time a new member is appointed.

Formation Description:	The District was formed on August 20, 1945 by resolution upon petition to the Board of Supervisors of citizens who are owners of land located within the proposed district pursuant to Health and Safety Code Section 9000.
Function / Purpose:	Provide communities with the means to publicly finance the ownership, improvement, expansion, and operation of public cemeteries and the provision of interment services, particularly in rural and formerly rural communities.
Structure:	The District is governed by a Board of Trustees consisting of (3) trustees appointed by the Board of Supervisors from the electors residing with the District pursuant to Health and Safety Code Section 9024.
Terms:	The trustees shall hold office for four (4) years and until the appointment and qualifications of their successors pursuant to Health and Safety Code Section 9024.
Meeting Dates and Location	The trustees meet as directed by the President, and as required to manage the affairs of the District.

Formation Description:	The advisory board was formed pursuant to Resolution No. 69-110 and is governed by Welfare and Institutions Code Section 5600 et seq. On March 23, 1993, AB 1288 Section 85 amended from Section 5604.2 of the Welfare and Institutions Code.
Function / Purpose:	The powers and duties of this organization are to: <ol style="list-style-type: none">1. Review and evaluate the community's behavioral health needs, services, facilities, and special challenges;2. Review County agreements entered into pursuant to Section 5650;3. Advise the Board of Supervisors and the local mental health director as to any aspect of the local mental health program;4. Review and approve the procedures used to ensure citizen and professional involvement at all stages of the planning process;5. Submit an annual report to the governing body on the needs and performance of the County's mental health system;6. Review and make recommendations on applications for the appointment of a local director of mental health services. The Board shall be included in the selection process prior to the vote of the governing body.7. Review and comment on the county's performance outcome data and communicate its findings to the California Behavioral Health Planning Council.8. Additional duties as assigned by the Board of Supervisors9. Assess the impact of the realignment of services from the state to the county, on services delivered to clients and on the local community.
Structure:	The Board shall have at least thirteen (13) members. One (1) member shall be a Board of Supervisor. One-half of the board membership shall be consumers, or the parents, spouses, siblings, or adult children of consumers, who are receiving or have received mental health services. At least 20% of the total membership shall be consumers, and at least 20% shall be families of consumers. One (1) member shall be a member of the Board of Supervisors. One member shall represent Law Enforcement. One member shall represent youth. Six (6) members shall be community members if the Behavioral Health Board comprises fifteen (15) members. No member of the Board or his or her spouse shall be a full-time or part-time employee of the Department of Behavioral Health, an employee of the State Department of Mental Health, or an employee of, or a member of the governing body of a contract agency with the Department of Behavioral Health. Members are appointed by the Board of Supervisors.
Terms:	The term of each member of the Board shall be for a period of three (3) years to generally expire on December 31 of the appropriate year. The youth representative shall serve for one (1) year. One-third of the terms

shall expire each year. No member shall serve more than two (2) consecutive three-year appointments with the exception that if a member has been appointed to a partial term, he/she may then be appointed to two full three-year terms. When one year has elapsed following a former member's service on the Board, or whatever duration that service was, he/she again becomes eligible for appointment.

Formation Description:	The Butte County Code Enforcement Advisory Board was established on January 29, 2002, pursuant to Resolution No. 02-021.
Function / Purpose:	<p>The purpose of the Board is to provide advice to the Board of Supervisors on code enforcement matters, and assist in the development of priorities in code enforcement activities, identification of programs for voluntary property clean-up, and funding opportunities for code enforcement and community clean-up programs.</p> <p>The Board shall review and monitor code enforcement activities in other communities, grants and other funding opportunities that may support such efforts, and provide advice and guidance to the Board of Supervisors. The Board shall provide a forum for the discussion of code enforcement issues, including code enforcement concerns of the general population of Butte County, and identify code enforcement problems and potential solutions.</p>
Structure:	The Advisory Board consists of five (5) members. Each member of the Board of Supervisors shall appoint one member of the Advisory Board.
Terms:	Members serve at the pleasure of the Board. There are no term limits.

Formation Description:	When redevelopment agencies dissolved, oversight boards were established to supervise the activities of the successor agencies that assumed the assets and responsibilities of the former redevelopment agencies. Within Butte County, individual jurisdictions each have their own successor agency and oversight board, with the exception of the City of Biggs. In accordance with Senate Bill No. 107 (SB107), Health and Safety Code Section 34179(j), the four (4) oversight boards in Butte County consolidated into one Countywide Oversight Board commencing July 1, 2018.
Function / Purpose:	The Butte County Consolidated Oversight Board will supervise the activities of the four (4) successor agencies within Butte County.
Structure:	<p>The required makeup of the Butte County Consolidated Oversight Board appointments are as follows:</p> <ol style="list-style-type: none">1) One member may be appointed by the County Board of Supervisors2) One member may be appointed by the City Selection Committee established pursuant to Section 50270 of the Government Code. In a city and county, the mayor may appoint one member3) One member may be appointed by the Independent Special District Selection Committee established pursuant to Section 56332 of the Government Code, for the types of special districts that are eligible to receive property tax revenues pursuant to Section 341884) One member may be appointed by the County Superintendent of Education to represent schools if the superintendent is elected. If the County Superintendent of Education is appointed, then the appointment made pursuant to this paragraph shall be made by the County Board of Education5) One member may be appointed by the Chancellor of the California Community Colleges to represent community college districts in the County6) One member of the public may be appointed by the County Board of Supervisors7) One member may be appointed by the recognized employee organization representing the largest number of successor agency employees in the County.
Terms:	Terms are unspecified.

Formation Description: The Butte County Fair Association began as a nonprofit corporation on September 24, 1937, and was known at that time as the Paradise Fair and Apple Show Association. On April 6, 1939, the nonprofit corporation changed its name to the Butte County Fair Association. On March 22, 1946, the Board of Supervisors adopted a resolution declaring the County's intent to hold and conduct an annual fair known as the Butte County Fair. Since then, the County has acquired fairgrounds in the City of Gridley, erected buildings and other facilities on the fairgrounds and entered into an agreement with the Butte County Fair Association to annually hold and conduct the Butte County Fair.

Function / Purpose: The purpose of the organization shall be to act in an advisory capacity to the Board of Supervisors concerning the conduct and management of the Fairgrounds and the Butte County Fair.

Structure: The Board of Directors shall consist of eight (8) members four (4) of which shall constitute a quorum. Four (4) members of the Board of Directors shall be residents of the Fourth Supervisorial District as appointed by said Supervisor from that district, and the remaining members shall be selected on the basis of one (1) resident from each of the remaining Supervisorial Districts, as appointed by said Supervisor from that district to represent their Supervisorial District. Should a Supervisor be unable to appoint within their district, due to a lack of desire or interest on behalf of community members from said district, then said Supervisor can appoint outside of their district but within the boundaries of Butte County.

Terms: The term of office of each director shall coincide with the elected term of the County Supervisors that nominates one for appointment, except that two of the four District 4 appointees shall serve a term which coincides with the elected terms of the District 2 and District 3 supervisors. Terms will commence on the first Monday following the first Friday in January of the respective year of appointment and said term will terminate on the first Monday following the first Friday in January in the fourth year thereafter or upon removal by the appointing Board of Supervisor member. The Board of Supervisors may remove a member of the Board of Directors at any time without cause. Any person appointed by the Board of Supervisors to fill a vacancy in the Board of Directors shall take office immediately and shall serve for the unexpired term of the person who ceased to be a director, until removed or until a successor is appointed. All directors are eligible for reappointment.

Meeting Dates and Location The annual meetings are held at the Administrative Offices of the Butte County Fair Grounds (199 East Hazel Street, Gridley, CA 95948), at 6:00 pm on the third Tuesday in January of each calendar year. The

- Formation Description:** At the December 10, 2013 meeting, the Board of Supervisors directed staff to set up a citizen's advisory committee to advise the Board on issues pertaining to U.S. Forest Service lands and other public lands. On April, 22, 2014, the Board of Supervisors approved the structure and the bylaws for this committee, pursuant to Resolution No. 14-043.
- Function / Purpose:** The purpose and duties of the Forest Advisory Committee shall be to serve as a stakeholder and informational resource on the following issues in Butte County: 1) Review Schedule of Proposed Actions (SOPAs) issued quarterly by the US Forest Service (USFS) as they pertain to Butte County; 2) Work with USFS prior to the issuing of SOPAs to influence USFS decisions; 3) Review impacts of USFS, Bureau of Land Management (BLM), State Recreation Area (SRA), and Recreation & Park District's (RPD) actions on Butte County as they pertain to agriculture, recreation, the environment, water quality, and the economy (including tourism); 4) Review Butte County General Plan and other land use issues pertaining to public land; 5) Build comment histories on USFS, SRA, and other public land projects; 6) Seek participation and comment from members of the public; and 7) Through the Coordination Committee, make recommendations to the Board of Supervisors for projects or policies that serve the interests of Butte County's citizens in their pursuit of enjoyment and protection of public lands.
- Structure:** The committee shall be comprised of five (5) public members and five (5) alternates from the public. Each member is appointed by the Butte County Board of Supervisors, after the application process, in the following five (5) areas of expertise/interest: Agriculture/Timber Management; Recreation-Motorized; Recreation-Non-Motorized; Environmental & Watershed Management; and Economic/Tourism. One (1) member from the Butte County Coordinating Committee (a County department head) appointed by the Board will serve as a non-voting ex officio member of the FAC.
- Terms:** Public members of the FAC will serve four-year terms. Terms shall be staggered by lot for two (2) years at the onset two (2) members will serve an initial term of two (2) full years and the portion of the calendar year ending December 31, and three (3) members will serve an initial term of four (4) full years and the portion of the 5th year ending December 31). The term of appointment for FAC members shall coincide with the calendar year and shall expire on December 31. Formation Description:	This Committee was established on April 13, 2004, pursuant to Resolution No. 04-057, which was amended by Resolution No. 09-014. The establishment of the Committee was a result of the approval of Senate Bill 621 which established a method for distributing funds from the Indian Gaming Special Distribution Fund to local government agencies impacted by tribal gaming. The Special Distribution Fund was established for the receipt and deposit of money received by the State of California from Indian tribes pursuant to terms of their gaming compacts.
Function / Purpose:	The Committee is established pursuant to Paragraph (1) of subsection (b) of Section 12715 of the California Government Code. It is the responsibility of the Committee to facilitate the distribution of appropriations from the Indian Gaming Distribution Fund by selecting those grants from each Individual Tribal Account or County Tribal Casino Account that will be applied toward the support of local government agencies within the County impacted by tribal government gaming.
Structure:	The Committee shall be composed of five (5) members consisting of the following, or as may be otherwise required by law: 1) Two (2) representatives from the County, appointed by the County Board of Supervisors; 2) One (1) elected representative from cities located within four (4) miles of a tribal casino in the County, appointed by the County Board of Supervisors based upon nominations from the City Council(s); and 3) Two (2) representatives selected upon the recommendation of a majority of the tribes paying into the Indian Gaming Special Distribution Fund in the County. If there are no tribes in the County paying into the Indian Gaming Special Distribution Fund, the two representatives may be selected upon the recommendation of the tribes operating casinos in the County.
Terms:	Terms of office of the members shall be four (4) years expiring on June 30 of the appropriate years and subsequent new terms shall begin July 1 of that year. The first term of office shall be deemed to commence on July 1, 2004 only for purposes of subsequent appointment of members. (For all other purposes, the first set of committee members commenced their terms on April 27, 2004.) A member whose term of office has expired shall continue to serve in that capacity until a new appointment is made. Members may be removed from the Committee at any time by a majority vote of the Board of Supervisors.

The vice-president, in the event of the absence or disability of the president, or a vacancy in that office, shall assume and perform the duties and functions of the president. The secretary shall be responsible for assuring the record of all meetings is true and accurate, that notices of all meetings are issued, that the financial reports are properly filed, and shall generally perform all other duties associated with that office.
Terms:	The Designees shall serve a term of one year from the annual meeting at which they are elected and until their successors are duly elected. All other members serve terms designated by the appointing authority.

Formation Description: The Butte County Library Advisory Board was established by Resolution No. 02-060 on April 23, 2002 and amended by Resolution No. 11-078 on July 26, 2011.

Function / Purpose: The Library Advisory Board is created for the following purposes:

- 1) To update and annually maintain a strategic plan for the Butte County Library;
- 2) To develop and maintain a long range library financial plan;
- 3) To provide an annual statement/report on the state of the Library for the past year;
- 4) To develop fundraising plans for the Board of Supervisors' approval;
- 5) To provide oversight of the funds deposited with the North Valley Community Foundation on behalf of the Butte County Libraries, as authorized on May 15, 2002 by the Board of Directors of the Butte County Library Foundation and prior to the closure of the Foundation;
- 6) To oversee the development of relationships with community partners, such as schools and businesses;
- 7) To assist with the relationships with the cities and town in the County;
- 8) To advise the Board of Supervisors on issues and trends impacting the Library;
- 9) To monitor technology that will affect the operation of the library and provide guidance to the Board of Supervisors;
- 10) To develop and oversee public relations campaigns in support of the Library; and
- 11) To encourage in every possible way the development and advancement of the public library system.

The Library Advisory Board will also investigate the requirements for setting up a non-profit foundation to assist in supporting the Butte County Library system, with the intent that any such foundation established shall not be established by Butte County or the Butte County Library Advisory Board

Structure:

Section 1. The Board shall have ten members appointed by the Butte County Board of Supervisors.

Section 2. The Board of Supervisors shall appoint ten members to the Advisory Board. Two members shall be appointed from each supervisorial district and shall reside within that supervisorial district.

Section 3. The Butte County Librarian shall be a non-voting member of the Board.

Section 4. The term for a member shall be for four (4) years.

Section 5. Vacancies shall be filled for an unexpired term.

Section 6. Absence from three (3) consecutive meetings without a valid reason, approved by the Board, will be considered as automatic resignation from the Board.

Terms: Members will serve terms concurrent with the appointing supervisor. Members are appointed for four (4) year terms which correspond with the appointing Supervisor. The initial terms will be staggered with Districts 2 and 3 expiring January 7, 2019 and Districts 1, 4 and 5 expiring January 4, 2021. Members will serve at the pleasure of the Board of Supervisors. The Advisory Board will elect a Chair and Vice-Chair at the first meeting of each calendar year. Officers shall serve a one-year term, or until replaced. If the Chair becomes vacant, the position shall be filled for the unexpired term by the Vice-Chair. If the office of Vice-chair becomes vacant, the office shall be filled by a vote of the Advisory Board. If both offices become vacant, both will be filled for the unexpired term by a vote of the Advisory Board.

Meeting Dates and Location Meetings shall be held a minimum of four (4) times per year, or as necessary as determined by a majority vote of the Advisory Board. The Advisory Board shall address the Board of Supervisors annually at a minimum, as an independent advocate for the Library.

Formation Description: The Commission was formed in 2018 by Senate Bill 955 - Oroville Dam: Citizens Advisory Commission, under Water Code section 6600et seq., and the composition of the members representing Butte County on the Commission was adopted by Resolution No. 19-030.

Function / Purpose: The Commission functions as a liaison between the communities surrounding the Oroville Dam and the dam operator and publishes a report regarding maintenance, improvements, and flood mitigation.

Pursuant to Water Code section 6606, the Commission shall do all of the following:

- A. Serve as a representative to the public for the purposes of proving public input and receiving information from the dam operator.
- B. Act as a unified voice from the communities surrounding Oroville Dam to provide public feedback, advice, and best practices to the dam operator.
- C. Publish a report at least once every three years that provides all of the following:
 - 1. An overview of ongoing maintenance and improvements made at the dam and its site.
 - 2. A register of communications received from the department and other parties to the Commission.
 - 3. Notice of upcoming plans made by the department for the dam and its site.
 - 4. An overview of flood management projects on the Feather River affecting public safety and flood risk reduction.
- D. The Commission may request, from the department's division of Flood Management or the reclamation or flood management district with jurisdiction over the Feather River, or any combination of those entities, levee system visits, briefings, or information regarding Feather River levees and levee-related flood risk.
- E. The Commission shall not make regulations or rules to bind operations at the dam.

Structure: The Commission consists of representatives from various State agencies, the State Senator representing the City of Oroville, and the State Assembly Member representing the City of Oroville. Additionally, the Chair of the Commission shall invite: two members appointed by the Oroville City Council; three members appointed by the Butte County Board of Supervisors; two members appointed by the Sutter County Board of Supervisors; two members appointed by the Yuba County Board of Supervisors; and a deputy sheriff from each of the following jurisdictions: Butte County, Sutter County, and Yuba County.

Pursuant to Resolution No. 19-030, the Board of Supervisors shall appoint the two supervisors who serve on the Federal Energy Regulation Commission Relicensing Ad Hoc Committee, and one member of the public.

Terms: Members of the Commission serve for three years.

Formation Description: The Commission was formed with Section 130100 of Division 108 of the Health and Safety Code and Butte County Ordinance No. 3470 after California voters passed Proposition 10, the California Children and Families Act, in 1998. The Commission has since been amended by Ordinance No. 3517, 3555, 3853, 3888, 4169.

Function / Purpose: The Commission's general purpose shall be to promote, support and improve the early development of children from the prenatal stage through five years of age through the creation and implementation of an integrated, comprehensive and collaborative system of information and services to enhance early childhood development.

Structure: The Commission shall be composed of nine (9) members appointed by the Board of Supervisors:

- 1) the Director-Public Health, or his or her designee;
- 2) the Director-Employment and Social Services, or his or her designee;
- 3) one member of the Board of Supervisors chosen from its members; and
- 4) six members appointed by the Board of Supervisors chosen from the following groups (with the intent that representatives from as many groups as possible will serve on the Commission):
 - (a) recipients of project services as set forth in the county strategic plan;
 - (b) educators specializing in early childhood development;
 - (c) representatives of a local group for prevention or intervention for families at risk;
 - (d) representatives of community based organizations that have a goal of promoting nurturing and early childhood development;
 - (e) representatives of local school districts;
 - (f) representatives of local medical, pediatric, or obstetric associations or societies;
 - (g) The county health officer and/or persons responsible for the management of the following county functions: children's services, public health services, behavioral health services, social services, and tobacco and other substance abuse prevention and treatment services;
 - (h) representatives of a local child care resource or referral agency, or a local child care coordinating group.

The Board of Supervisors shall appoint five (5) alternate members to the commission utilizing the process provided in this code. The five (5) alternate members shall attend all meetings of the commission and may participate in the discussion of items at the meeting. In the event less than five (5) alternates are needed to serve as replacement members for a specific meeting; the alternates selected to replace commission members for a specific meeting shall be selected by lot. An alternate

shall not be eligible to vote on an item unless the alternate has been selected to replace a commission member for a specific meeting.

Terms:

Each member, except those members specifically set forth in the Health and Safety Code, shall serve for a term of two (2) years. At the conclusion of a term, a member may be appointed to a new term. As directed by Amended Ordinance No. 3555, June 10, 2003, term ending dates will be June 30 of even and odd years. The term of alternate members appointed by the Board of Supervisors shall be consistent with the term of regular members.

Registered Environmental Health Specialist9. Wastewater component vendor or proprietor (*)10. Citizen-at-Large
Terms:	Committee members shall serve four-year terms, effective June 1, 2010, and may be reappointed for consecutive terms by the Board of Supervisors. When the Board of Supervisors first establishes the Committee, those membership categories with the asterisk (*) shall be appointed for two (2) years for the initial term and four (4) years for each term thereafter. . In addition to the membership of the Committee, representatives from the Technical Advisory Committee may participate in the meetings as a non-voting technical resource to the Committee. Description:**

The Wyandotte Creek GSA was created through the Wyandotte Creek Joint Powers Agreement executed on September 18, 2018. The Member Agencies include Butte County, the City of Oroville and Thermalito Water and Sewer District. The Wyandotte Creek GSA Board of Directors consists of one seat for each Member Agency, an Agricultural Stakeholder Director and a Domestic Stakeholder Director. Each designated seat will have an appointed alternate. Alternate Directors shall have no vote and shall not participate in any discussions or deliberations of the Board unless appearing as a substitute for a Director due to absence or conflict of interest. If the Director is not present, or if the Director has a conflict of interest which precludes participation by the Director in any decision-making process of the Board, the Alternate Director appointed to act in his/her place shall assume all rights of the Director and shall have the authority to act in his/her absence, including casting votes on matters before the Board. Each Alternate Director shall be appointed prior to the third meeting of the Board. Alternate Directors are encouraged to attend all Board meetings and stay informed on current issues before the Board.

**Function /
Purpose:**

The Wyandotte Creek GSA is the exclusive agency responsible for implementing the provisions of the Sustainable Groundwater Management Act and specifically for developing and implementing the groundwater sustainability plan pursuant to the Sustainable Groundwater Management Act.

Structure:

The Butte County Board of Supervisors has three appointments and three alternates to the Wyandotte Creek GSA Board of Directors.

1. Member of the Butte County Board of Supervisors (primary)
2. Member of the Butte County Board of Supervisors (alternate)
